3. Main New Functionalities and Major Changes

• <u>eHealth Addressbook</u>

eHealth Addressbook is a generic address book for the Belgian health care sector. The user (sender, i.e. a natural person or an organization) is able to consult the received data (available in CoBRHA) through this web service and to decide which communication method is the most adequate for the recipient and the communication in question. This enables the senders (authorities, for instance) to develop flexible communication strategies.

• Uniek Portaal / Portail unique WA (AKA lanua)

The "Uniek Portaal/Portail Unique" should become the single access point for the healthcare professional where he/she can consult and change his personal and professional data known by the authorities (Federal, Regional,...)

The healthcare professional only has to communicate this information once. All healthcare actors share the most up to date and reliable information on the healthcare professional (stored in Cobhra)
