DÉLIBÉRATION N° 20/286 DU 1^{ER} DÉCEMBRE 2020 RELATIVE À LA COMMUNICATION DE DONNÉES À CARACTÈRE PERSONNEL PSEUDONYMISÉES RELATIVES À LA SANTÉ ISSUES DE L'ENQUÊTE BELGE DE SANTÉ 2013 PAR SCIENSANO À L'UNIVERSITÉ CATHOLIQUE DE LOUVAIN (UCL), DANS LE CADRE D'UNE ÉTUDE RELATIVE À L'UTILISATION DE LA PILULE CONTRACEPTIVE EN BELGIQUE, FRANCE ET SUISSE

Vu le règlement (UE) n°2016/679 du Parlement européen et du Conseil du 27 avril 2016 relatif à la protection des personnes physiques à l'égard du traitement des données à caractère personnel et à la libre circulation de ces données, et abrogeant la directive 95/46/CE (règlement général sur la protection des données) ;

Vu la loi du 3 décembre 2017 portant création de l'Autorité de protection des données, notamment l'article 114, modifié par la loi du 25 mai 2018 ;

Vu la loi du 30 juillet 2018 *relative à la protection des personnes physiques à l'égard des traitements de données à caractère personnel*;

Vu la loi du 13 décembre 2006 *portant dispositions diverses en matière de santé*, en particulier l'article 42, § 2, 3°, modifié par la loi du 5 septembre 2018;

Vu la loi du 15 janvier 1990 *relative à l'institution et à l'organisation d'une Banque-carrefour de la sécurité sociale*, notamment l'article 37 ;

Vu la loi du 5 septembre 2018 *instituant le comité de sécurité de l'information et modifiant diverses lois concernant la mise en œuvre du Règlement (UE) 2016/679 du Parlement européen et du Conseil du 27 avril 2016 relatif à la protection des personnes physiques à l'égard du traitement des données à caractère personnel et à la libre circulation de ces données, et abrogeant la directive 95/46/CE*, notamment l'article 97 ;

Vu la loi du 21 août 2008 *relative à l'institution et à l'organisation de la plate-forme eHealth* ;

Vu la demande d'autorisation de l'UCL ;

Vu le rapport d'auditorat de la Plate-forme eHealth ;

Vu le rapport de monsieur Bart Viaene ;

Émet, après délibération, la décision suivante, le 1^{er} décembre 2020 :

I. OBJET DE LA DEMANDE

A. L'ENQUÊTE BELGE DE SANTÉ

1. En 2012, l'Institut scientifique de santé publique¹ (ISP) désormais Sciensano, a été chargé, notamment pour l'autorité fédérale, les Communautés et les Régions, de l'organisation quinquennale d'une enquête nationale de santé au moyen d'une interrogation d'un échantillon de la population belge. Les résultats permettent de déterminer les besoins réels en matière de santé de la population belge, d'établir des rapports entre l'état de santé, certains facteurs (le mode de vie, l'environnement, le statut socio-économique, ...) et l'utilisation de soins de santé (préventifs ou curatifs) et de soutenir les décisions politiques en matière de santé publique.
2. L'enquête de santé nationale est effectuée sous la responsabilité de l'ISP qui, pour certains aspects pratiques (en particulier l'extraction de l'échantillon et l'interrogation des personnes de l'échantillon), fait cependant appel aux services de la Direction générale Statistique et Information économique du Service public fédéral Economie, PME, Classes moyennes et Energie en qualité de sous-traitant.
3. L'enquête quinquennale est réalisée, sur base volontaire, auprès d'un échantillon aléatoire pondéré d'au moins dix mille personnes domiciliées en Belgique. Cet échantillon est extrait du registre national des personnes physiques par la Direction générale Statistique et Information économique – 3.500 personnes en provenance de la Flandre, 3.500 en provenance de la Wallonie et 3000 personnes en provenance de Bruxelles (en 2013, 450 personnes des provinces de Namur et de Luxembourg ont été ajoutées, à la demande explicite des autorités compétentes).
4. Les données à caractère personnel, qui sont recueillies au moyen des interviews, sont pseudonymisées par la Direction générale Statistique avant d'être mises à la disposition de l'ISP. Ce codage consiste dans le remplacement du numéro d'identification de la sécurité sociale de chaque intéressé par un numéro d'ordre sans signification. La Direction générale Statistique est la seule à conserver le lien entre les deux numéros.
5. L'ISP procède à un deuxième codage et conserve les données à caractère personnel doublement codées sur un serveur spécifique. Lorsqu'un accès est autorisé pour un tiers, ce dernier reçoit un login et un mot de passe personnalisés lui permettant de télécharger les données de l'ISP.
6. La section Santé du Comité sectoriel a formulé une recommandation positive concernant le traitement de données à caractère personnel dans le cadre de l'enquête nationale de santé (recommandation n° 12/03 du 20 novembre 2012).
7. L'AIM a réalisé en juillet 2015 une analyse de risque "*small cell*" sur l'ensemble des données à caractère personnel codées obtenues lors de l'enquête nationale de santé organisée en 2013,

afin d'exclure la possibilité de réidentification des intéressés. Le Comité a reçu le rapport de cette analyse.

B. COMMUNICATION D'UNE SÉLECTION DE DONNÉES À CARACTÈRE PERSONNEL PSEUDONYMISÉES RELATIVES À LA SANTÉ

8. Une étudiante du Centre de recherche en démographie de l'UCL, sous la supervision du Professeur Bruno Schoumaker, souhaite obtenir une sélection de données à caractère personnel relatives à la santé pseudonymisées issues de l'enquête de santé 2013.
9. Cette étude est effectuée dans le cadre d'une thèse de doctorat. Il s'agit d'une étude relative aux risques liés à la contraception orale en Belgique, en France et en Suisse. Cette étude a pour but d'évaluer l'impact de la diminution du recours à la contraception médicale dans certains groupes socio-économiques et évaluer les inégalités sociales en matière de santé reproductive.
10. La chercheuse souhaite utiliser des données quantitatives et qualitatives disponibles au sein de ces 3 pays. En ce qui concerne la Belgique, la chercheuse souhaite obtenir une sélection de données pseudonymisées issues de l'enquête de santé 2013 afin de développer les hypothèses suivantes :
 - 1° comparer la manière dont les trois systèmes nationaux de soins de santé distincts participent à la création d'inégalités sociales en matière de santé reproductive ;
 - 2° comparer les tendances de l'utilisation des contraceptifs par les hommes et les femmes, afin d'évaluer si la baisse de l'utilisation de la pilule a pu conduire à une augmentation de la participation des hommes au « travail contraceptif » ;
 - 3° Etudier l'évolution des déterminants du choix de la méthode contraceptive en fonction du milieu socio-économique des individus afin de savoir si l'évolution des usages contraceptifs après la récente controverse médiatique sur les pilules résulte d'une augmentation des inégalités de santé reproductive ou d'une distinction dans les déterminants du choix de la méthode contraceptive.
11. Les données à caractère personnel relatives à santé pseudonymisées suivantes sont communiquées par Sciensano au demandeur² :
 - Une sélection de données issues du module 1 - caractéristiques sociodémographiques des individus ayant participé à l'enquête et de leur ménage ;
 - Une sélection de données issues du module 2, soit les sous-modules 2.1 (santé perçue) et 2.2 (maladies chroniques) ;
 - Une sélection de données issues du module 3, soit les sous-modules 3.2 (consommation de tabac) et 3.8 (santé sexuelle) ;

- Une sélection de données issues du module 4, soit les sous-modules 4.1 (contact avec un professionnel de santé), 4.2 (contact avec un spécialiste), 4.9 (utilisation de médicaments), 4.10 (accès financier au services de santé) et 4.11 (expérience des patients) ;

- Une sélection de données issues du module 6, soit les données relatives aux recours aux soins de prévention.

12. Les données pseudonymisées communiquées seront conservées par l'UCL sur un serveur sécurisé jusqu'au 1^{er} janvier 2028.

II. COMPÉTENCE

13. En vertu de l'article 42, § 2, 3°, de la loi du 13 décembre 2006 *portant dispositions diverses en matière de santé*, la chambre sécurité sociale et santé du Comité de sécurité de l'information est en principe compétente pour l'octroi d'une autorisation de principe concernant toute communication de données à caractère personnel relatives à la santé.

14. La chambre sécurité sociale et santé du Comité de sécurité de l'information s'estime dès lors compétente pour se prononcer sur la présente demande.

III. EXAMEN

A. ADMISSIBILITÉ

15. Le traitement de données à caractère personnel relatives à la santé est en principe interdit, et ce conformément au prescrit de l'article 9, §1er, du Règlement (UE) 2016/679 du Parlement européen et du Conseil du 27 avril 2016 relatif à la protection des personnes physiques à l'égard du traitement des données à caractère personnel et à la libre circulation de ces données et abrogeant la directive 95/46/CE (règlement général sur la protection des données), ci-après dénommé RGPD.

16. Selon l'article 9, §2, j), du RGPD, cette interdiction ne s'applique pas lorsque ce traitement est nécessaire à des fins de recherche scientifique ou à des fins statistiques, conformément à l'article 89, §1er, sur la base du droit de l'Union ou du droit d'un Etat membre qui doit être proportionné à l'objectif poursuivi respecter l'essence du droit à la protection des données et prévoir des mesures appropriées et spécifiques pour la sauvegarde des droits fondamentaux et des intérêts de la personne concernées.

17. A la lumière de ce qui précède, le comité de sécurité de l'information est par conséquent d'avis qu'il existe un fondement admissible pour le traitement des données à caractère personnel pseudonymisées relatives à la santé envisagé.

B. PRINCIPES RELATIFS AU TRAITEMENT DES DONNÉES À CARACTÈRE PERSONNEL

18. Selon l'article 5 du RGPD, les données à caractère personnel doivent être traitées de manière licite, loyale et transparente au regard de la personne concernée. Elles doivent être collectées

pour des finalités déterminées, explicites et légitimes, et ne pas être traitées ultérieurement d'une manière incompatible avec ces finalités.

19. Le demandeur déclare que l'objectif de la demande est d'évaluer l'impact de la diminution du recours à la contraception médicale dans certains groupes socio-économiques et évaluer les inégalités sociales en matière de santé reproductive en Belgique, France et Suisse.
20. Au vu des objectifs du traitement tels que décrits ci-dessus, le Comité de sécurité de l'information considère que le traitement des données à caractère personnel envisagé poursuit bien des finalités déterminées, explicites et légitimes.
21. L'article 5, §1^{er} du RGPD dispose que les données à caractère personnel doivent être adéquates, pertinentes et limitées à ce qui est nécessaire au regard des finalités pour lesquelles elles sont traitées (minimisation des données).
22. Le demandeur déclare que le traitement des différentes données à caractère personnel pseudonymisées demandées est nécessaire pour les raisons suivantes :
 - *Une sélection de données issues du module 1 - caractéristiques sociodémographiques des individus ayant participé à l'enquête et de leur ménage* : ces données sont indispensables à nos analyses pour caractériser la situation conjugale/familiale des individus (âge, en couple, nombre d'enfants) et spécifier leur appartenance sociale (situation socio-économique) ;
 - *Une sélection de données issues du module 2 soit les sous-modules 2.1 (santé perçue) et 2.2 (maladies chroniques)* : les informations demandées permettront de savoir si certaines méthodes de contraception sont contre-indiquées pour raisons de santé (l'usage de contraceptifs hormonaux n'est pas indiqués chez les femmes souffrant de migraines ou ayant des antécédents de maladies cardio-vasculaires) ;
 - *Une sélection de données issues du module 3 soit les sous-modules 3.2 (consommation de tabac) et 3.8 (santé sexuelle)* : les informations quant à la santé sexuelle sont les variables d'intérêt de notre recherche. Par ailleurs, les données relatives à la consommation de tabac pourraient nous informer sur les raisons liées à l'utilisation des différentes méthodes de contraception : l'association pilule-tabac étant fortement déconseillée chez les femmes après 35 ans ;
 - *Une sélection de données issues du module 4 soit les sous-modules 4.1 (contact avec un professionnel de santé), 4.2 (contact avec un spécialiste), 4.9 (utilisation de médicaments), 4.10 (accès financier aux services de santé) et 4.11 (expérience des patients)* : les informations relatives aux services de santé nous permettront de mieux caractériser les difficultés d'accès aux services de santé. Les informations relatives à l'utilisation des médicaments nous permettront de connaître le type de contraceptif utilisé par les femmes (marque de la pilule) ;
 - *Une sélection de données issues du module 6 soit les données relatives aux recours aux soins de prévention* : ces données nous permettront à la fois de mieux qualifier le suivi

gynécologique des femmes mais également de mieux connaître leur état de santé, notamment en ce qui concerne les risques cardiovasculaires. Les données relatives aux connaissances du VIH et le recours aux tests de dépistage seront mises en lien avec le recours au préservatif.

23. Le Comité constate, en outre, que la variable relative à l'âge des individus est communiquée soit en catégories, soit en années. La chercheuse souhaite également obtenir la communication de l'année de naissance de l'individu afin de réaliser une étude plus précise et réaliser une étude générationnelle. Le Comité estime que cette requête est acceptable à condition que l'année de naissance soit disponible au sein de la base de données de Sciensano. Si l'obtention de cette variable nécessite un couplage avec les données de Statbel, une demande de modification de la présente délibération devra être introduite par le demandeur.
24. Le principe de proportionnalité implique que le traitement doit en principe être réalisé au moyen de données anonymes. Cependant, si la finalité ne peut être réalisée au moyen de données anonymes, des données à caractère personnel pseudonymisées peuvent être traitées. Vu la nécessité de réaliser des analyses très détaillées à l'aide de ces données, le demandeur a besoin d'avoir accès à des données pseudonymisées afin d'être en mesure de réaliser des analyses très détaillées qu'il ne serait pas possible de réaliser à l'aide de données anonymes. Cette finalité justifie donc le traitement de données à caractère personnel pseudonymisées.
25. Le Comité de sécurité de l'information estime que les données à caractère personnel qui seraient transmises au demandeur sont effectivement de nature pseudonymisées puisque le numéro d'identification utilisé pour les membres d'un ménage est codé une première fois par la Direction générale de la Statistique et une deuxième fois, spécifiquement pour le projet, par Sciensano.
26. Le Comité de sécurité de l'information constate qu'une analyse de risques "*small cell*" a été réalisée en 2015 sur l'ensemble des données à caractère personnel codées de la banque de données de l'enquête de santé 2013³.
27. Lors de l'organisation de l'enquête de santé, les ménages sélectionnés reçoivent une lettre d'invitation et un dépliant informatif expliquant ce qu'est l'enquête de santé, le type de questions qui seront posées lors de l'interview et les institutions susceptibles d'utiliser ces données. Il est également précisé que la participation à cette enquête n'est pas obligatoire. Les intéressés sont informés du fait que leurs données à caractère personnel seront traitées de manière codée à des fins de recherche scientifique.
28. Le Comité de sécurité de l'information est d'avis qu'il existe suffisamment de transparence quant au traitement envisagé.
29. Conformément à l'article 5, §1^{er}, e), les données à caractère personnel doivent être conservées sous une forme permettant l'identification des personnes concernées pendant une durée

n'excédant pas celle nécessaire au regard des finalités pour lesquelles elles sont traitées. Les données sont demandées seront conservées par le demandeur jusqu'au 1^{er} janvier 2028. Cette durée de conservation est prévue au-delà de la fin de la période de bourse postdoctorale dans l'hypothèse où une révision des articles soumis à des revues scientifiques serait nécessaire.

30. Le Comité de sécurité de l'information dit que ce délai de conservation est raisonnable et précise que les données à caractère personnel pseudonymisées devront être détruites au plus tard le 1^{er} janvier 2028. Le Comité rappelle que les données pseudonymisées devront être conservées au sein d'un serveur sécurisé.
31. Selon l'article 5, §1^{er}, f) du RGPD, les données à caractère personnel doivent être traitées de façon à garantir une sécurité appropriée des données à caractère personnel, y compris la protection contre le traitement non autorisé ou illicite et contre la perte, la destruction ou les dégâts d'origine accidentelle, à l'aide de mesures techniques ou organisationnelles appropriées (intégrité et confidentialité).
32. La chambre sécurité sociale et santé rappelle qu'en vertu de l'article 9 de la loi du 30 juillet 2018 *relative à la protection des personnes physiques à l'égard des traitements de données à caractère personnel*, le responsable du traitement prend les mesures supplémentaires suivantes lors du traitement de données génétiques, biométriques ou des données concernant la santé :
 - 1° les catégories de personnes ayant accès aux données à caractère personnel, sont désignées par le responsable du traitement ou, le cas échéant, par le sous-traitant, avec une description précise de leur fonction par rapport au traitement des données visées;
 - 2° la liste des catégories des personnes ainsi désignées est tenue à la disposition de l'autorité de contrôle compétente par le responsable du traitement ou, le cas échéant, par le sous-traitant;
 - 3° il veille à ce que les personnes désignées soient tenues, par une obligation légale ou statutaire, ou par une disposition contractuelle équivalente, au respect du caractère confidentiel des données visées.
33. Le Comité de sécurité de l'information constate que les données seront traitées sous la responsabilité d'un professionnel des soins de santé.

Par ces motifs,

la chambre sécurité sociale et santé du comité de sécurité de l'information

conclut que

la communication des données à caractère personnel telle que décrite dans la présente délibération est autorisée moyennant le respect des mesures de protection de la vie privée qui ont été définies, en particulier les mesures en matière de limitation de la finalité, de minimisation des données, de limitation de la durée de conservation des données et de sécurité de l'information.
