3. Main new functionalities and minor changes

3.1 Therapeutic Link Attribute (HCI 213)

Extension of the propagation of therapeutic links principles from HCI 212 to HCI 213 in CoBRHA

3.2 Software register

The goal of this application is to create a shared database that will be a centralized unique source for the data related to software packages in the e-health domain.

Implementation of the following functionalities of the Web App and Web Service Contacts, Organizations, services, Log-in and Log Out.

3.3 DICS V5.2

New operations findStandardDosage and findImportedMedicinalProductPackage.

The existing concept Standard Dosage has been reworked to better match with the data structures at the data provider. This means the old structures are obsolete. A new operation has been created to request the Standard Dosages based on a VMP Group Id. The old structures remain in the contract for retro-compatibility, but will never be used (so nothing changes there).

The new concept ImportedMedicinalProduct describes Medicinal Products that are not available on the Belgian market, but can be imported for specific needs. We only have limited data on these products, so a specific interface has been provided to search for these products.

3.4 UHMEP

The goal of this project is to digitalize referral prescriptions and proposals to facilitate their processing and exchange among different stakeholders: the patient, the caregiver, and the prescriber.
