2. Introduction

IAM Connect allows registered clients to obtain tokens. Different tokens may be issued to the client depending on its configuration (access token, ID token , refresh token).

The ID token is a JSON Web Token (JWT) that contains information about the user such as username, given name, last name, and other profile information.

The access token is a JSON Web Token (JWT). It is digitally signed by the realm and contains access information (like user role mappings) that the client can use to determine what resources the user is allowed to access on the client application. Access token can be used by the client to make call REST invocations on other remote services on behalf of the user.

The refresh token can be used to obtain a renewed access token.

The goal of this document is to provide explanations on eHealth IAM Connect claims generated after the end user selected a profile (returned in ID token and/or access token) and to map them with the IAM Attributes used for web SSO solution.

Clients using client credentials flow are not affected by these mappers.

Currently it exists 2 types of claim mappers (both return the same information but in a different format):

- Claim mappers v0
- Claim mappers v1

Claim mappers v0 is deprecated but still in use for few clients.



3. Mappers v0

Claim mappers v0 is deprecated.

Depending on the profile selected by the end user, IAM attributes will be mapped into claims.

Claim interpretation :

- **profile_opt** : type of profile selected by the user to access a protected resource (examples : USER, ORGANIZATION, MANDATE-USER)
- **ssin** : Social Security Identification number of the authenticated user
- **professional.id** : NIHDI (NIHII) number of the individual healthcare professional (11 digits identifier)
- **professional.type** : quality of the authenticated user (examples : PHYSICIAN, NURSE, DENTIST)
- **org.id** : Identifier of organization represented by authenticated user.
- **org.type** : Type of identifier of organization represented by authenticated user (examples : HOSPITAL, ENTERPRISE, LABO, EHP).
- **org.name** : Name of organization represented by authenticated user
- **mandator.id** : Identifier of the actor who gave a mandate to the authenticated user.
- **mandator.type** : Type of identifier of the actor who gave a mandate to the authenticated user (examples : CITIZE, NURSE, GROUPOFNURSES, LABO, ENTERPRISE).
- **mandator.name** : Name of the actor who gave a mandate to the authenticated user.
- **mandator.death_date** : Death date of the individual person who gave a mandate.
- **mandator.status** : Status of the individual person who gave a mandate (possible values : ALIVE, DEAD, UNKNOWN).



- **child.id** : Identifier (NISS/SSIN) of the actor being a child of the authenticated user
- **child.given_name** : Given name of the child selected by the authenticated user
- **child.family_name** : Family name of the child selected by the authenticated user

4. Mappers v1

Claim mappers v1 SHOULD be used for every client using WebAccess¹.

Depending on the profile selected by the end user, IAM attributes will be mapped into claims.

The information of the selected profile by the authenticated user is contained into one claim “userProfile” that has a JSON structure.

4.1 Claims

Claim interpretation (non-exhaustive list) :

- **userProfile.ssIn** : Social Security Identification number of the authenticated user
- **userProfile.firstName** : Given name of the authenticated user
- **userProfile.lastName** : Last name of the authenticated user



- **userProfile.\$ProfessionType³.nihii11** : NIHDI number of the individual healthcare professional (11 digits identifier)
- **userProfile.\$ProfessionType⁴.recognised** : Boolean value indicating if the healthcare professional is recognised by the authentic source (FPS Public Health)
- **userProfile.organizations[0].name** : Name of organization represented by authenticated user
- **userProfile.organizations[0].\$OrgType⁵.\$IdType⁶** : Identifier, type of identifier and type of organization selected by the authenticated user.
- **userProfile.mandators[0].ssin** : Identifier of the individual actor who gave a mandate to the authenticated user.
- **userProfile.mandators[0].firstName** : Given name of the individual actor who gave a mandate to the authenticated user.
- **userProfile.mandators[0].lastName** : Last name of the individual actor who gave a mandate to the authenticated user.
- **userProfile.mandators[0].name** : Last name + first name of the individual actor who gave a mandate to the authenticated user.
- **userProfile.mandators[0].\$ProfessionType⁷.recognisednihii11** : NIHDI number of the individual healthcare professional who gave a mandate to the authenticated user (11 digits identifier) if the healthcare professional is recognised by the authentic source (FPS Public Health)
- **userProfile.mandators[0].organizations.name** : Name of organization who gave a mandate to the authenticated user
- **userProfile.mandators[0].\$OrgType.\$IdType**: Id of the organization who gave a mandate to the authenticated user
- **userProfile.children[0].ssin** : Identifier (SSIN) of the actor being a child of the authenticated user
- **userProfile.children[0].firstName**: Given name of the child selected by the authenticated user
- **userProfile.children[0].lastName** : Family name of the child selected by the authenticated user
